**1. Foreword**

Dear reader,

Please find enclosed the provisional decision of the Central Executive Board for Student Associations (CUOS) regarding the Internationalization and Inclusion grant (IIS) for 2024. The decisions in this document are provisional. Organizations that applied may make their opinions known before the decision becomes final. For more information about the working methods and methods used for assessment, please refer to the first chapter. Chapter 4 onwards provides an overview of the IIS per organization, along with a substantive evaluation of the application concerned.

With regard to the applications for, and allocation of, grants, please refer to the overview in Chapter 3. The total amount requested for Internationalization and Inclusion grants per organization was higher than the upper limit available to the CUOS. As a result, the CUOS has had to make concessions on the basis of parameters set in line with the Internationalization and Inclusion grant regulations. This means that some student organizations have either not been allocated the full amount they requested, or have been allocated certain amounts for specific internationalization and/or inclusion activities. This enabled the CUOS to weigh up the total costs against the total benefits, and divide sums as fairly and proportionally as possible.

## **2. Working method**

### *General*

The aim of the IIS is to promote internationalization and inclusion in existing student organizations. Every organization can apply for a grant up to a maximum of €1,000. The ceiling for grants in 2024 was set at €15,000. As illustrated by the overview of applications, the total amount requested this year substantially exceeded this ceiling. The CUOS tried to honour as many grant applications as possible, whether fully or partially, but it retained the right, in line with Article 4(4) of the Internationalization and Inclusion grant regulations (hereinafter: the Regulations), to decide which applications were the most eligible for being allocated a grant.

The CUOS works in accordance with the CUOS Regulations and the Regulations. This provisional decision ensues from the CUOS task of assessing the organizations that apply for the IIS. Every organization will be sent a letter setting out this provisional decision after the publication of this document. The CUOS will give the organizations an opportunity to take note of the provisional decision and make their views known within 10 working days, in line with Article 9(4) of the Regulations. If an organization makes its views known within this period, the CUOS will make a definitive decision as soon as possible and inform the organization of this new decision. If an organization does not make its views known, the provisional decision will become final by operation of law.

Accountability for the activities for which the grant was allocated is set out in Article 10 of the Regulations.

### *Deadline*

As was the case last year, organizations had until 11.59 p.m. on 31 March 2024 to submit an application. This deadline was set to give organizations extra time after the deadline for activity grants and housing elapsed on 1 February. Additional documents were gathered during the first weeks after the deadline, after which the applications were processed in detail. Once a complete application has been processed, the provisional decision was communicated to the organization concerned.

### *Evaluation*

The CUOS evaluates applications according to the following criteria, as set out in Article 7 of the Regulations: the content, aim, target group and scope, approach, PR plan, amount and reasonableness, opportunity to acquire own income, and ratio of

requested amount to own budget. As well as these substantive evaluation criteria, in accordance with Article 8 of the Regulations, a number of weighting factors were also taken into account in the evaluation: the diversity in the range of activities, support, the contribution to academic development, and compliance of the plan with UG policy. The most important weighting factor is whether the activity contributes to the integration and inclusion of international and Dutch students.

As was the case last year, CUOS also considers the financial need of the application, in line with Article 3 of the Regulations. Amounts that have been requested for activities that mainly involve eating and drinking, or for general promotional material, are only honoured for 50%, in accordance with Article 3(3). In addition, in view of the grant ceiling and Article 4(4), the CUOS has allocated half of the requested amount for food and drink for all other activities. On the grounds of Article 3(4), this year the CUOS has not allocated funding for alcoholic drinks, and applications for grants purely to cover alcoholic drinks were rejected. With regard to professional translations, the CUOS will reimburse the full cost of translating essential documents (including Articles of Association), but funding will not be allocated for the translation of non-essential documents, such as internal regulations.

## **4. Individual decisions**

### **4.1 ACLO**

#### *Organization*

This year, the student association ACLO:

- applied for €1,000;
- submitted their application in time and in full.

#### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that ACLO:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID NOT apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

#### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided NOT to allocate a grant to ACLO for 2024 for the purposes of translating the multi-year plan. Article 3(4) of the Regulations states that the CUOS does not allocate funding for the translation of non-essential documents.

## **4.2 ACSA**

### *Organization*

This year, the organization African Caribbean Student Association (ACSA):

- applied for €1,000;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that ACSA:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €500 to ACSA for 2024. The CUOS is allocating this grant for the purposes of organizing the symposium. The CUOS is allocating the grant on the condition that it must not be spent on alcoholic drinks. Also, in accordance with Article 3(4) of the Regulations, the CUOS is not allocating funding to financially compensate members and the association in general.

### **4.3 AEGEE**

#### *Organization*

This year, the Association des États Généraux des Étudiants de l'Europe - Groningen (AEGEE-Groningen):

- applied for €396.06;
- submitted their application in time and in full.

#### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that AEGEE:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

#### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €396.06 to AEGEE for 2024. The CUOS is allocating this grant for the purposes of Europe Week and the Panel Discussion. The CUOS is allocating the grant on the condition that it must not be spent on alcoholic drinks, in accordance with Article 3(4) of the Regulations.

#### **4.4 Amicus Civitas**

##### *Organization*

This year, the organization Amicus Civitas:

- applied for €955;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Amicus Civitas:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID NOT apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €0 to Amicus Civitas for 2024. The application cited regular activities, without specifically international or inclusive dimensions, which is not in line with Articles 7 and 8 of the Regulations.

## **4.5 Groene Uilen-Moestasj**

### *Organization*

This year, the organization Groene Uilen-Moestasj:

- applied for €1,000;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Groene Uilen:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €125 to Groene Uilen-Moestasj for 2024, for the specialized wheelchair 3x3 On Wheels at the 3x3NL Groningen Tournament GUM. The CUOS is not allocating funding for the LoCs and travel expenses, as the CUOS does not allocate financial compensation to members, in accordance with Article 3(4) of the Regulations.

## **4.6 Bulgarian Society Groningen (BGSB)**

### *Organization*

The organization BGSB:

- applied for €1,000;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that BGSB:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €1,000 to BGSB for 2024. The CUOS is allocating this grant for the purposes of the Spring Gala. The CUOS is allocating the grant on the condition that it must not be spent on alcoholic drinks.



## **4.7 Caerus**

### *Organization*

The organization Caerus:

- applied for €900;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Caerus:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €900 to Caerus for 2024. The CUOS is allocating this grant for the purposes of the Cultural Awareness and Inclusivity Programme. The CUOS is allocating the grant on the condition that it must not be spent on alcoholic drinks.

## **4.8 Clio**

### *Organization*

This year, the organization Club for the International Relations and International Organization programme (Clio):

- applied for €845.42;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Clio:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €281.22 to Clio for 2024. The CUOS is allocating this grant for the purposes of stickers and a flag for the 'Raising Awareness LGBTQ+' initiative. The CUOS has decided not to allocate the entire amount requested in view of the reasonableness of the costs in accordance with Article 7(5) and the scope of this part of the initiative in accordance with Article 7(3) of the Regulations.

## **4.9 Commotie**

### *Organization*

This year, the organization Commotie:

- applied for €60;
- submitted their application in time and in full.

### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Commotie:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €60 to Commotie for 2024 for the purposes of hiring a venue for the International Dance activity.

#### **4.10 Cover**

##### *Organization*

The organization Cover:

- applied for €250;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Cover:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €125 to Cover for 2024. The CUOS is allocating this grant so that the language exchange café can hire a location and serve coffee and tea. The CUOS has reduced the amount by 50% in accordance with Article 3(3) of the Regulations and is allocating the grant on the condition that it may not be spent on alcoholic drinks.

#### **4.11 EBF**

##### *Organization*

The organization EBF:

- applied for €1,000;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that EBF:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID NOT apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS NOT demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided NOT to allocate funding to EBF for 2024. The limited size of the target group and the scope of the international development project do not satisfy the required criteria for an internationalization and inclusion grant in accordance with Article 7(3) of the Regulations.

#### **4.12 ELSA**

##### *Organization*

This year, the organization Elsa:

- applied for €140;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that ELSA:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €120 to ELSA for 2024. The CUOS is allocating this grant for the purposes of the discussion evening 'Moving forward together' and the exchange networking event.

#### **4.13 ESN Groningen**

##### *Organization*

The organization Erasmus Student Network (ESN):

- applied for €1,000;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that ESN:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €820 to ESN for 2024. The CUOS is allocating this grant for the purposes of the pub quiz and dinner on Integration Night. The CUOS does not allocate funding for alcoholic drinks, in accordance with Article 3(4) of the Regulations. In addition, the CUOS will allocate a maximum of 50% of amounts requested for food and drink in accordance with Article 3(3) of the Regulations. ESN is organizing Integration Night in collaboration with several other student organizations, but ESN is primarily responsible for providing accountability.

#### **4.14 Flanor**

##### *Organization*

The organization Flanor:

- applied for €600;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Flanor:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €600 to Flanor for 2024. The CUOS is allocating this grant for the purposes of paying the author's fee for the English lecture during the KEI week.



#### **4.15 FSG**

##### *Organization*

The organization Financial Study association Groningen (FSG):

- applied for €1,000;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that FSG:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €450 to FSG for 2024. The CUOS is allocating this grant for the purposes of setting up an integration committee and the international introduction dinner. The CUOS is allocating the grant on the condition that it must not be spent on alcoholic drinks. Activities primarily focusing on eating and drinking may not account for more than 50% of the costs, in accordance with Article 3(3) of the Regulations. In addition, the CUOS does not allocate funding to financially compensate members and the association in general, in line with Article 3(4) of the Regulations.

#### **4.16 G.S.B.C. AMOR**

##### *Organization*

The organization AMOR:

- applied for €80;
- did NOT submit their application on time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that AMOR:

- DOES meet the general requirements;
- HAS sufficiently demonstrated the extent to which the organization is currently internationalized;
- DID apply for a grant for projects or activities eligible for funding, which contribute sufficiently to the internationalization of student organizations and/or inclusion of Dutch and international students in Groningen;
- HAS demonstrated a financial need for support from the CUOS.

##### *Decision regarding Internationalization and Inclusion grant*

The CUOS has decided to allocate €0 to AMOR for 2024. This is because AMOR was too late in submitting the compulsory documents for the IIS application. A term was offered to remedy this, but the organization did not respond, even after repeated calls.

#### **4.17 G.S.P.V. de Ramenlappers**

##### *Organization*

The organization G.S.P.V. de Ramenlappers:

- applied for €1,000;
- submitted their application in time and in full.

##### *Evaluation for Internationalization and Inclusion grant*

The CUOS has assessed that Ramenlappers:
