1. Foreword

2. Working Method

2.1 General

The CUOS operates in line with the CUOS Regulations. This provisional decision is based on the task of assessing associations that wish to be eligible for the CUOS scheme for supporting student associations in amending their Articles of Association to comply with the Management and Supervision of Legal Entities Act (*WBTR*). Every association has been sent a letter informing them of the provisional or final decision. The matter of whether a decision is provisional or final depends on whether the association concerned has already amended its Articles of Association.

2.2 Deadline

All associations were approached at the start of this academic year and advised to submit an application for a *WBTR* grant. A reminder was sent to the associations shortly before the 30 April deadline. Additional documents were still being gathered in the first few weeks after the deadline. In principle, the CUOS upholds a strict deadline. Exceptions may be made in special cases. This year, all of the applications were approved for processing.

2.3 Assessment

Applications are assessed against the conditions stated in Article 5 of the CUOS Regulations on *WBTR* grants; the CUOS regulations for supporting student associations when amending their Articles of Association to comply with the *WBTR*. It must be stressed here that the CUOS assesses the associations based on the information provided and subsequently requested. Assessments cannot be made on the basis of documents that are not supplied.
