## Impact Case: Financial inclusion in Pakistan



Much of Dr. Syedah Shan E Ahmad's and Dr. Annika Mueller's collaborative research focuses on microfinance and financial inclusion in Islamic countries. The empirical findings of their research, conducted in collaboration with Professor Robert Lensink, contributed to the redesign of two key features of a savings account to facilitate formal banking access for economically disadvantaged individuals, offered by Pakistan's largest Islamic bank, Meezan Bank. The implemented changes have had a significant impact on financial inclusion in Pakistan. [Read further](#)
