Section 1 General provisions

The Master's degree programme in Arts and Culture comprises seven Master's tracks Music, Theatre and Performance Studies; Film and Contemporary Audiovisual Media; Arts, Policy and Cultural Entrepreneurship; Arts, Cognition and Criticism (following on from the Bachelor's degree programme in Arts, Culture and Media (ACM)); Art History; History of Architecture & Town Planning; and Landscape History (following on from the Bachelor's degree programme in Art History).

Article 1.1 – Applicability

These Regulations comprise two parts – Part A and Part B. This degree programme-specific Part B accompanies Part A, which contains general provisions that apply to the teaching, examinations and final assessments of the Master's degree programmes provided by the Faculty of Arts, hereinafter referred to as **the Faculty**. Part B contains stipulations that specifically concern the Master's degree programme in **Arts and Culture**.

Section 2 Admission

Article 2.1 – Entry requirements

1. Students with a Dutch or foreign certificate of higher education that indicates that they have acquired the following knowledge, skills and attitudes at university Bachelor's level will be admitted to the degree programme:

- for the tracks Art History, History of Architecture & Town Planning and Landscape History: knowledge and understanding of, and skills relevant to, the field of art history
- for the tracks Music, Theatre and Performance Studies; Film and Contemporary Audiovisual Media; Arts, Policy and Cultural Entrepreneurship; Arts, Cognition and Criticism: knowledge and understanding of, and skills relevant to, the field of arts, culture and media.

In addition, the Master's tracks are also open to students who have completed a different Bachelor's or Master's degree programme in a field relevant to these tracks as well as to students who have completed the pre-Master's degree programme that prepares for the track. The Admissions Board will assess this.

2. If a candidate does not have a Bachelor's degree, the Admissions Board will assess whether he/she can be admitted based on the possession of relevant knowledge, understanding and skills at Bachelor's level.

9. If a candidate does not have a Bachelor's degree, the Admissions Board will assess whether he/she can be admitted based on the possession of relevant knowledge, understanding and skills at Bachelor's level.

Article 2.2 – Language requirements for students with foreign qualifications

1. Students who have been admitted to a degree programme on the basis of a foreign certificate or degree may be required by the Board of Examiners – before registration – to pass an *English* language test, to be administered by an agency stipulated by the Board of Examiners.
2. The English language proficiency requirement can be met by passing an examination in English at the level of the VWO final exam or by passing the TOEFL iBT with a score of at least 90, with a minimum score of 21 on each individual part, or an IELTS score of 6.5, with a minimum score of 6.0 on each individual part.

Section 3 Content and structure of the degree programme

Article 3.1 – Student workload

1. The degree programme has a student workload of 60 ECTS. However, the *Museum & Curatorial Studies* specialization has a student workload of 90 ECTS.
2. The student workload is expressed in whole ECTS credit points.

Article 3.3 – Language

1. The degree programme is taught in English, with the exception of the track *Landschapsgeschiedenis* (Landscape History).
2. Notwithstanding Article 3.3.1, one or more course units of the programme may be taught in Dutch if the composition of the student group justifies this.
3. Written assignments and the thesis/final assignment must be written in Dutch or English. These products may only be written in a language other than Dutch or English if the supervising lecturer has given permission to do so.

Section 4 Tests and examinations of the degree programme

Article 4.1 – Compulsory order

The examinations for the course units listed below may not be taken before the examinations for the associated course units have been passed:

MA placement in Arts and Culture	Students must have earned at least 20 ECTS in other course units before they can start their placement and thesis. Students of the Museum and Curatorial Studies specialization of the Art History track may only start their placement once they have submitted their thesis (although it does not need to have been assessed yet).

Section 5 Transitional and final provisions

Article 5.1 – Amendments

1. Any amendments to Part A of these Regulations will, after due consultation with and, if necessary, upon the approval of the Faculty Council, be confirmed by the Faculty Board in a separate decree.
2. Any amendments to Part B of these Regulations will, following a recommendation by and/or upon the approval of the Programme Committee and the Faculty Council, be confirmed by the Faculty Board in a separate decree.
3. Any amendments to these Regulations will not apply to the current academic year, unless it may reasonably be assumed that the amendment in question will not harm the interests of students.
4. In addition, an amendment may not influence any other decision concerning a student taken by the Board of Examiners under these Regulations to the disadvantage of students.

Article 5.2 – Publication

1. The Faculty Board will duly publish these Regulations, any rules and guidelines formulated by the Board of Examiners, and any amendments to these documents.
2. Copies of the documents referred to in Article 5.2.1 are available from the Faculty Office. These documents can also be found on the Faculty website through the Student Portal.

Article 5.3 – Date of commencement

These Regulations will take effect on 1 September 2018.

These regulations were decreed by the Board of the Faculty of Arts on 22 January 2019, with approval from the Faculty Council and the Programme Committee for the sections requiring this by law.
