## **Section 1** General provisions

The Master's degree programme in Arts and Culture comprises seven Master's tracks Music, Theatre and Performance Studies; Film and Contemporary Audiovisual Media; Arts, Policy and Cultural Entrepreneurship; Arts, Cognition and Criticism (following on from the Bachelor's degree programme in Arts, Culture and Media (ACM)); Art History; History of Architecture & Town Planning; and Landscape History (following on from the Bachelor's degree programme in Art History).

## Article 1.1 - Applicability

These Regulations comprise two parts – Part A and Part B. This degree programme-specific Part B accompanies Part A, which contains general provisions that apply to the teaching, examinations and final assessments of the Master's degree programmes provided by the Faculty of Arts, hereinafter referred to as **the Faculty**. Part B contains stipulations that specifically concern the Master's degree programme in **Arts and Culture**.

#### Section 2 Admission

#### **Article 2.1 – Entry requirements**

- 1. Students with a Dutch or foreign certificate of higher education that indicates that they have acquired the following knowledge, skills and attitudes at university Bachelor's level will be admitted to the degree programme:
  - for the tracks Art History and Landscape History: knowledge and understanding of, and skills relevant to, the field of art history
  - for the track History of Architecture & Town Planning: knowledge and understanding of, and skills relevant to, the fields of either Architecture, Art History, Spatial Planning, Archaeology, History, urban studies, or design studies
  - for the tracks Music, Theatre and Performance Studies; Film and Contemporary Audiovisual Media; Arts, Policy and Cultural Entrepreneurship; Arts, Cognition and Criticism: knowledge and understanding of, and skills relevant to, the field of arts, culture and media.

In addition, the Master's tracks are also open to students who have completed a different Bachelor's or Master's degree programme in a field relevant to these tracks as well as to students who have completed the pre-Master's degree programme that prepares for the track. The Admissions Board will assess this.

- 2. If a candidate does not have a Bachelor's degree, the Admissions Board will assess whether he/she can be admitted based on the possession of relevant knowledge, understanding and skills at Bachelor's level.

from the University of Groningen, with a Faculty Minor **History in Art, Architecture and Landscape** are eligible for admission to the Master Arts & Culture tracks Art History, History of Architecture and Town planning, and Landscape History only via the Master Admission Board. When a specially composed trajectory within this Faculty Minor ('personal minor'), approved by the

exam committee, is completed, students are expected to have the knowledge, understanding and skills listed in Article 2.1.1, and will be admitted to the relevant track in the degree programme on that basis.

  - Arts, Culture and Media (incl. Visual Art programme)

from the University of Groningen, are expected to have the knowledge, understanding and skills listed in Article 2.1.1, and will be admitted to the **Art History** track [specialization Modern & Contemporary Art] in the degree programme on that basis.

#### Article 2.2 - Language requirements for students with foreign qualifications

- 1. Students who have been admitted to a degree programme on the basis of a foreign certificate or degree may be required by the Board of Examiners before registration to pass an *English* language test, to be administered by an agency stipulated by the Board of Examiners.
- 2. The English language proficiency requirement can be met by passing an examination in English at the level of the VWO final exam or by passing the TOEFL iBT with a score of at least 90, with a minimum score of 21 on each individual part, or an IELTS score of 6.5, with a minimum score of 6.0 on each individual part.

# Section 3 Content and structure of the degree programme

#### Article 3.1 - Student workload

- 1. The degree programme has a student workload of 60 ECTS. The museum placement, as part of the *Curatorial Studies* specialization adds an extra workload of 30 ECTS.
- 2. The student workload is expressed in whole ECTS credit points.

## Article 3.3 - Language

- 1. The degree programme is taught in English, with the exception of the track Landschapsgeschiedenis (Landscape History).
- 2. Notwithstanding Article 3.3.1, one or more course units of the programme may be taught in Dutch if the composition of the student group justifies this.
- 3. Written assignments and the thesis/final assignment must be written in Dutch or English. These products may only be written in a language other than Dutch or English if the supervising lecturer has given permission to do so.

(\*)Students admitted to one of the tracks 1. APCE, 2. ACC, 3. MTPS or 4. FCAM choose for a minimum of 20 ects and a maximum of 25 ects course units offered in their specialisation track. Students choose 5 or 10 additional ects from one of the other tracks of the Arts & Culture master or a course outside the master on literature: provided they can demonstrate they meet the entry requirements of the chosen course units, and provided the scheduling of these courses is compatible with that of the compulsory courses in the track. (*Media, Materials, Makers: Art and/as Research* can be chosen, but available places are limited: students of the Art History track and the Arts, Cognition and Criticism track of the MA Arts & Culture take precedence). Students may also choose two MA course units on Literature offered by other departments in the Faculty of Arts, provided Literature was one of the arts disciplines in their Bachelor's programme. Students in the ACC and APCE tracks may also choose 10 ECTS MA course units from the AH track, provided art history was one of the arts disciplines in their Bachelor's programme and provided there is enough capacity in the course, which first has to cater to students within the track. Permission for alternative arrangements can be requested from the Exam Committee. Students unable to secure an internship will be permitted to enroll in the 10ECTS internship replacement course *Arts in Society - Practical Approaches*.

All course units are listed in the online course catalogue OCASYS.

- 2. The modes of instruction and assessment for the course units listed above are set out in the syllabus for each individual course unit and the assessment plan for the degree programme.
- 3. In situations of force majeure, when it is not reasonably possible to provide teaching in the manner stated in OCASYS, alternative modes of instruction and assessment may temporarily be used.

This is on condition that the prescribed learning outcomes are still achieved upon completion of the degree programme.

# **Section 4** Tests and examinations of the degree programme

#### Article 4.1 - Compulsory order

The examinations for the course units listed below may not be taken before the examinations for the associated course units have been passed:

# Section 5 Transitional and final provisions

#### **Article 5.1 – Amendments**

- 1. Any amendments to Part A of these Regulations will, after due consultation with and, if necessary, upon the approval of the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 2. Any amendments to Part B of these Regulations will, following a recommendation by and/or upon the approval of the Programme Committee and the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 3. Any amendments to these Regulations will not apply to the current academic year, unless it may reasonably be assumed that the amendment in question will not harm the interests of students.
- 4. In addition, an amendment may not influence any other decision concerning a student taken by the Board of Examiners under these Regulations to the disadvantage of students.

#### **Article 5.2 - Publication**

- 1. The Faculty Board will duly publish these Regulations, any rules and guidelines formulated by the Board of Examiners, and any amendments to these documents.
- 2. Copies of the documents referred to in Article 5.2.1 are available from the Faculty Office. These documents can also be found on the Faculty website through the Student Portal.

## **Article 5.3 – Date of commencement**

These Regulations will take effect on 1 September 2024.

These regulations were decreed by the Board of the Faculty of Arts on 21 August 2024, with approval from the Faculty Council and the Programme Committee for the sections requiring this by law.
