Section 1 General provisions

Article 1.1 - Applicability

These Regulations comprise two parts – Part A and Part B. This degree programme-specific Part B accompanies Part A, which contains general provisions which apply to the teaching, examinations and final assessments of the Master's degree programmes provided by the Faculty of Arts, hereinafter referred to as **the Faculty**. Part B contains provisions which apply to **the degree programme in Arts and Culture** (hereinafter referred to as 'the degree programme') and its two corresponding tracks.

Section 2 Admission

Article 2.1 - Entry requirements

- 1. Students with a Dutch or foreign certificate of higher education that indicates that they have the following knowledge, understanding and skills can apply to the degree programme:
 - a) Disciplinary and general knowledge relevant to the tracks in this programme, in addition to satisfying the other entry requirements listed below; more specifically, for AMLS, depending on the student's disciplinary orientation, knowledge at Bachelor's level of art history, art education, media and journalism studies, film studies, literary studies, music studies, theatre studies, or cultural theory and cultural studies. For CL knowledge is required of any humanities discipline or discipline relevant to leadership in the cultural domain at Bachelor's level;
 - b) good English proficiency (see 2.2)
 - sufficient knowledge, understanding and skills in the academic disciplines, as well as a sufficient level of theoretical and methodological insight and knowledge, relevant to the degree programme and Research Master's track
 - d) academic competences (such as analytic capacities, self-discipline) and affinity with research, as attested through their grades, BA thesis, reference letters and their own motivation letter.

Article 2.2 – Language requirement for foreign certificates

- 1. Students who have been admitted to a degree programme on the basis of a foreign certificate or degree are asked by the Admissions Board before registration to pass an English language test, to be administered by an agency stipulated by the Admissions Board.
- 2. The requirement of an English language proficiency requirement is met by passing an examination in English at the level of the VWO final exam, or by passing the TOEFL iBT with a score of at least 100 (with a minimum score of 25 for the component 'writing') or an IELTS score of 7 or higher (with a minimum score of 6.5 for all components).

Article 2.3 - Admission to Research Master's tracks

In addition to the provisions of Article 2.1, the following admission requirements apply to the various Research Master's tracks in this degree programme: n/a

Article 2.4 - Registering for the admissions procedure

Students register for the admissions procedure by submitting the following documents:

- a completed registration form
- a curriculum vitae
- an overview of the results achieved so far within the Bachelor's degree programme and/or other university degree programmes
- a letter outlining the prospective students' motivation for selecting the programme and Research Master's track, including their expectations and interests
- written results of previous research, such as academic articles or a Bachelor's thesis

- two personal recommendations from staff members who can comment on the students' affinity with and capacities for research ¹
- other documents, if required, which in the opinion of prospective students will highlight their eligibility for the programme and Research Master's track.

Article 2.5 – Admissions procedure for the degree programme

- 1. Bearing in mind the admissions procedure for the degree programme and the Research Master's track with regard to Article 2.1.1, the Admissions Board will assess the knowledge and skills of the candidate. The Admissions Board will assess the written documentation and determine whether the prospective student can be admitted directly to the programme and the Research Master's track. In the event of doubt, the student will be invited to an admissions interview. The interview will be based on questions raised by the submitted written documentation.
- 2. If, on the basis of the submitted documentation, the Board is of the opinion that the student does not qualify for admission and that there is therefore no need for an interview, the student will be notified accordingly before 15 June. This decision is *provisional*. Prospective students may still request an interview, provided they do so within 15 working days. If prospective students do not avail themselves of this option, the provisional decision will become *definitive*. In the case of prospective students who are granted an interview, a formal decision will not be made until after the interview has taken place. Rejections will in all cases be substantiated in writing. Students who have been interviewed will be notified by 15 July whether or not they have been accepted.²
- 3. Students who have not yet obtained their Bachelor's degree at the time of the selection procedure but who would normally do so before the Research Master's degree programme begins may be granted provisional admission, if it can be reasonably assumed that they a) obtain their Bachelor's degree in time and b) have written a BA thesis of the required level to follow the Research Master.
- 4. For students who already have a relevant university Master's degree but who wish to apply for admission to the degree programme, the same admission procedure applies. If they are admitted, the Board of Examiners will decide whether they can be granted exemptions on the basis of their previous Master's degree (up to a maximum of 60 ECTS credit points).

Article 2.6 – Entrance examination: times

- 1. The standard entrance examination will be held in June, as the degree programme commences in the first semester. Starting the programme in the second semester is formally possible, but the programme does not encourage this option. In this case the admission procedure is conducted in December/January.
- 2. Requests for admission to the degree programme and the Research Master's track must be submitted to the Admissions Board before 1 May (EU students and non-EU students); alternately, for starting in semester 2, before 15 October.
- 3. In exceptional cases, the Admissions Board may decide to consider a request at a time other than that referred to in Article 2.6.2.
- 4. The Admissions Board will decide before 15 June, alternately, before January 20. Admission will be on condition that the candidate has met the requirements set out in Article 2.4 concerning knowledge and skills by the starting date of the degree programme at the latest, supported by certificates from the completed degree programmes. The written admission statement will include information for the student about the possibility of an appeal to the Board of Appeal for Examinations.

Section 3 Content and structure of the degree programme

Article 3.1 – Student workload

1. The degree programme has a student workload of 120 ECTS.

¹ These are written reports from people recognized as experts by the Admissions Board that present a useful and reliable picture of the student's eligibility for the degree programme.

² Proof of admission is discussed in Article 7.30b of the Higher Education and Research Act.

2. The student workload is expressed in whole ECTS credit points.

Article 3.2 – Learning outcomes of the degree programme

B. Applying knowledge and understanding

The ability to apply their knowledge and understanding, and problem solving abilities in new or unfamiliar environments within broader (or multidisciplinary) contexts related to their field of study; have the ability to integrate knowledge and handle complexity.

B1. the capacity to formulate a research question that is relevant to their academic and, whenever appropriate, to the corresponding cultural and professional fields.

CL:

a. the ability to translate issues in areas of cultural leadership into adequate research questions.

AMLS:

b. the capacity to translate issues in societal and professional fields corresponding to one's expertise into adequate research questions.

B2. the capacity to select independently, apply and where necessary adapt a relevant research method, in order to **CL**:

a. critically analyse and evaluate academic research and independently set up and conduct theoretical and empirical scientific research into (aspects of) cultural leadership.

AMIS:

b. analyse and interpret some specific facet of the role of cultural arts and/or media - artefacts and practices (in both their material and immaterial forms) in society.

B3. the capacity to position and critically relate one's knowledge and research to issues, debates and developments in society as they impact (leadership in) one's chosen art or media field, and to debates and developments in the corresponding academic field(s), as well as, more broadly, in the Humanities, and, as a result, the capacity to fulfil a leading and/or advisory role in cultural organisations, or in starting up processes of change.

B4. the capacity to apply their knowledge of and insight into changing ideas, practices and (institutional) conditions regarding the arts and/or media and regarding being an artist or professional (in whatever art or media contexts) for concrete use in roles of policy advice, critical analysis for targeted or broad publics, or other professional use.

B5. the capacity to offer an original contribution in terms of theories, methods, analysis or interpretation to one or more sectors within the area of specialisation, at expert level, to the standards of the corresponding academic and professional settings. This implies the capacity to make an original contribution to at least one aspect of the study of (leadership regarding) the functioning of art and media in society, e.g. to the standard of an academic publication.

C. Making judgements

The ability to integrate knowledge and handle complexity, and formulate judgements with incomplete or limited information, but that include

C1. the capacity to understand and evaluate intellectual arguments and use their insights and capacity for judgement in professional contexts, taking into account institutional constraints. This implies the capacity:

reflecting on social and ethical responsibilities linked to the application of their knowledge and judgements.

- a. to connect one's specialist knowledge to other relevant forms of theorising and reflecting about the role of the arts and media in culture and society (e.g. philosophy, history, sociology, critical theory).
- b.to recognise and analyse the role of ideologies, values and particular interests in the concrete functioning of the arts and the media;
- c. to apply one's analytic and critical competences and expert knowledge to reach sound and convincing judgments and advice about concrete cases (e.g. in public debates about provocative art or media productions; in advising about policy in one's disciplinary areas), as well in leading, programming and decision-making roles in organisations in the cultural field, esp. in the fields of the arts and/or the media.
- C2. the capacity to deal creatively and systematically with complex issues and reach well-reasoned conclusions, taking into account social and ethical implications, and demonstrating leadership, responsibility and sensitivity to social context and ethics in handling situations in the academic and professional fields.

D. Communication

The ability to communicate their conclusions, and the knowledge and rationale underpinning these, to specialist and non-specialist audiences clearly and unambiguously.

- D1. the capacity to adequately present scientific research in different media, in English (and any other relevant language depending on subject and context), for an audience of specialists and non-specialists in the worlds of the arts and/or the media, in speech and writing as well as through audiovisual or digital media.
- D2. to be able to adequately communicate about and discuss their field of expertise, e.g. by debating one's own work and that of others in a sphere of mutual respect and constructive criticism.
- D3. the capacity to participate actively in a research group or other team, as well as in academic or societal debates on culture and cultural leadership and/or the role of the arts or the media in society.
- D4. the capacity to apply knowledge of the scientific code of conduct and ethics both with regard to referencing and using work and ideas of others, and with regard to the collection and processing of empirical data.

E. Learning skills

The learning skills to allow them to continue to study in a manner that may be largely self-directed or autonomous.

- E1. the capacity to demonstrate context sensitivity, to take into account and respectfully operate within situations marked by cultural and ideological differences.
- E2. the capacity to process large amounts of complex information efficiently and effectively.
- E3. the capacity to keep up the knowledge and skills necessary for keeping abreast with the developments in their area of specialisation, to deepen their own knowledge and insights and to employ these in the professional field.
- E4. the capacity to take initiative and the ability to reflect upon their own acts and academic attitude.
- E5. the ability to formulate a research proposal and conduct research, independently and in team settings, with the required self-discipline and realistic planning.

E6. the skills which are necessary for a successful professional practice. These include:

a) the ability to work independently in a complex (international) professional settings;

b) the ability to take a context-sensitive attitude and to attune – maintaining their integrity as a scholar – the results of their own work to the expectations and knowledge level of the intended audience, both independently and in a team;

c) the ability to take initiative and personal responsibility;

d) the ability to make decisions in complex and partly unpredictable situations;

e) the ability to anticipate and critically respond to trends

in one's chosen field.

Article 3.3 - Language of instruction

- 1. The degree programme is taught in English. However, some courses might be offered in Dutch or another language if that language is part of the expertise that is required for a student.
- 2. The thesis/final assignment must be written in English, unless the student's area of specialisation (or the cultural field or institution to which his/her thesis research pertains) requires the use of Dutch or of another language. For any other case, the permission of the Board of Examiners is required.

Article 3.4 – Specialisations

Arts, Media and Literary Studies:

Specialisations occurs in 3 ways:

- through the choice of electives (though these may also be used for broadening one's perspective)
- through 25 ECTS in the first semester of Year 2; specialisations take the form of a research internship, a (individual or group) tutorial, course work with additional assignment; this semester is important in determining a student's specialist profile.
- through the thesis, in which quite evidently the student's specialisation culminates.

Cultural Leadership:

The Research Master's track has no specialisations, though students in their course work, their Research Traineeship and in their Research Master's Thesis may (and in some cases will be encouraged) to focus on a particular aspect of cultural leadership and on a particular field or discipline to which such leadership pertains.

Article 3.5 - Content of the curriculum

N.B. The first semester (courses 1 to 4) is taught at RUG, the second semester can optionally be at Roma Tre University (here indicated with b in the course number). Course 5 is offered in hybrid form so students abroad can also follow it.

^{***} Electives are chosen from the relevant offer of MA courses (or tutorials) in the Faculty of Arts. Occasionally students can also take courses outside the Faculty, for instance at the faculties of Philosophy or Religious Studies, or outside of the University. Each of these choices are discussed with the students' mentor, and need to be approved by the Director of Studies. Courses outside of the University of Groningen also need to be approved by the Board of Examiners.

^{***} Each year two 'special topics' courses will be offered by alternating staff members. Students are required to do at least one of them (but are allowed to do more as electives). These are content-driven courses on state-of-the-art topics in the field of arts and media research, designed specifically for ReMA AMLS students. Since the topics change yearly students from both the first and second year can take these courses.

^{****} The specialization phase can be organized in different ways. Students can follow courses/tutorials in the field of their specialization, either at the UG but also at other universities. Students can also do a research traineeship, or an external internship, under the supervision of a staff member.

^{*****} Students must choose a total of 10 ECTS worth of course units offered by a national research school. In case the courses on offer by the National Research Schools do not suffice or are not compatible with the student's research orientation, comparable courses or activities may be opted for after agreement by the Director of Studies.

^{*} Disciplinary electives are master courses offered by any department within the Faculty of Arts (RUG) or Faculty of Studi Umanistici (Roma Tre), preferably in the student's area of specialisation, which in most cases is the discipline in which a student did his/her BA. Students may choose master courses offered by other faculties within both universities or other universities, but only after consultation with the Director of Studies and subsequent approval of the Board of Examiners. 10 ECTS are obtained during the first semester in Groningen, another 15

ECTS are obtained during the second semester in Rome (at Roma Tre University) if students chose the option to seek an exchange visit at Roma Tre. If not, students follow courses and tutorials in Groningen in the second semester.

** As in Italian universities 1 ECTS equals 24 student hours, whereas in Groningen 1 ECTS equals 28 student hours, course units indicated in the Roma Tre course guides of 6 ECTS count as 5 ECTS courses.

*** Students who have not passed the obligatory course units of the first year (i.e. courses 1, 3, 4, 5 and 6a or courses 1, 3, 4, 5 and 6b, 7b and 8b in the table above) are not allowed to start with the traineeship and thesis.

All course units offered by the Faculty of Arts in the University of Groningen are listed in the online course catalogue OCASYS.

2. The modes of instruction and assessment for the course units listed above are set out in the syllabus of each individual course unit and the assessment plan of the degree programme.

Section 4 Tests and examinations of the degree programme

Article 4.1 - Compulsory order

The examinations for the course units listed below may not be taken before the examinations for the associated course units have been passed:

SECTION 5 TRANSITIONAL AND FINAL PROVISIONS

Article 5.1 – Amendments

- 1. Any amendments to part A of these Regulations will, after discussion with and where necessary approval from the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 2. Any amendments to part B of these Regulations will, after the Departmental Board has put its case, following the recommendation by and/or upon the approval of the Programme Committee and the Faculty Council, be confirmed by the Faculty Board in a separate decree.
- 3. Any amendments to these Regulations will not apply to the current academic year, unless it may reasonably be assumed that the amendment in question will not harm the interests of students.
- 4. In addition, an amendment may not influence any other decision concerning a student taken by the Board of Examiners under these Regulations to the disadvantage of students.

Article 5.2 - Publication

- 1. The Faculty Board shall duly publish these Regulations, any rules and guidelines formulated by the Board of Examiners, and any amendments to these documents.
- 2. Copies of the documents referred to in Article 5.2.1 are available from the Faculty Office. These documents can also be found on the Faculty website via the Student Portal.

Article 5.3 – Date of commencement

These Regulations shall take effect on 1 September 2024.

These Regulations were decreed by the Board of the Faculty of Arts on 21 August 2024 and approved by the Faculty Council and the Programme Committee where required on.
