NWO grant on “Making the hidden visible: Co-designing for public values in standards-making and governance”

Dr Mando Rachovitsa (RuG, co-applicant) together with Prof Paul Groth (UvA, co-applicant), Dr Stefania Milan (UvA, main applicant) and the Dutch standardisation body were awarded a grant by the NWO for the project “Making the hidden visible: Co-designing for public values in standards-making and governance”.

The 4-year project (budget 750,000 euros) brings together the humanities, computer science and international law in order to better understand and investigate the relationship between societal values (e.g., openness, human rights, transparency, inclusion of all concerned parties, neutrality) and ICT standards on products, services and processes. The project asks the question: "To what extent can new approaches, methodologies, and technologies contribute in "wiring in" public values in standard-making?". The research will explore how standards can be value- and rights-respecting by design and it aims at designing a corresponding methodology and intelligent interventions to involve public and private actors. Three case studies are under investigation: (a) Applications of 5G Cellular Mobile Communication for Social Inclusion; (b) Global Identity Management Standards and Local Applicability; and (c) Development of Cybersecurity Standards for IoT. There will be strong collaboration with national stakeholders, including the Ministry of Foreign Affairs, Ministry of Justice & Security and the Municipality of The Hague, producing policy-relevant outcomes and finding ways for citizen participation in national and international ICT standard-setting processes.

Upgrading *TLS: TaLkS!*

It has been more than a year that we started to gather together every month and discuss our work-in-progress projects, papers, or ideas from our research. *TLS: TaLkS!* has proved to be a great way of building bridges and engaging in amazing discussions. This has been a great uniting experience, and we learned a lot from each other. Yet there is so much more to learn! This is why we are upgrading *TLS: TaLkS!* from January on. We believe that with the help of this seminar we can build strong and mutually beneficial ties between different sections of our department, which should go beyond mere acquaintance with our individual research projects. So meet the new shiny format of *TLS: TaLkS!*

First, we are making the seminar more inclusive so that we are more aware of current research affairs at the department. Our organisation team now includes Dr Evgeni Moyakine, and we hope that with his help *TLS: TaLkS!* will start featuring a much more balanced variety of topics.

Second, we are changing the announcement format. We know how challenging it may be to find time for *TLS: TaLkS!*, especially for those with a tight schedule. We have been trying our best to inform about the upcoming seminars for at least two weeks in advance, but this is still not an ideal solution. From January on, we will plan the seminars for three consecutive months (January-March-April, May-June-July, September-October-November), thus offering you more flexibility in building up your schedule. We will distribute the first announcement in the new format in the early January.

Finally, we would like to expand the seminar and offer it as a platform for external speakers as well. Our department has many ties with various research groups all around the country and *TLS: TaLkS!* may become a great way of strengthening those ties and we encourage our colleagues to submit proposals as to whom we could invite for a

presentation. We would therefore appreciate if you let us know in advance if you expect a guest so we can timely include him or her in our programme.

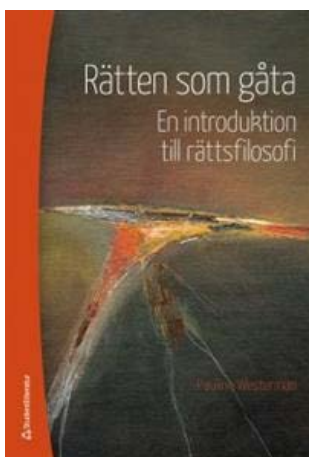

When I wrote the book I did not know that it would later be used in Lund and Stockholm. Every year I intend to remedy this defect, which I never actually carry out.

October 17 I was invited to give a speech on "The position of legal theory" at the workshop: "After Abstraction: Intellectual Thought in International Law", at Queen Mary University of London. It is a topic of which I virtually know nothing but -probably precisely for that reason- gave rise to an interesting debate.

The day after I departed for Shanghai University of Political Science and Law, where I was invited to give 4 lectures in the philosophy of law by Mrs Li Ze. Li Ze has been a guest lecturer at our department of legal theory in 2011 and we never lost contact. It was very nice to see her again and to get acquainted with her colleagues as well. Students were very eager to listen and even to discuss philosophical and political dilemmas in a way and at a level that I did not expect, despite the language problem.

Anne Ruth Mackor was invited by professor Yasushi Koide of the Shibaura Institute of Technology (SIT), Tokyo, Japan, to give keynotes on **Euthanasia in the Netherlands** in Tokyo and Kyoto. The audience consisted mainly of professors, lecturers and PhDs in the field of law, medicine and medical ethics. She explained the euthanasia law and the review practice in the Netherlands. One of the topics being discussed were the necessary conditions for a good, transparent and reliable law on and practice of euthanasia. Among others a good health care system and a constructive involvement of the medical association and an open discussion with the patient about his or her medical condition and prognosis are obviously essential. The latter, however, is not self-evident in Japan. Her presentation on Euthanasia has been translated in Japanese and will be published spring 2020.

A New Reading Group Format in the New Year: TLS Reads!

After one year of reading and discussions we are happy to announce that the Transboundary Legal Studies International Law Reading Group (**TLSIL Reading Group**) will go into 2020 with a new and improved format. In order to account for the various reading interests of members of our department we have decided to broaden the reading focus of the group, and open it up to more interested participants.

As of 2020, the reading group will focus on readings from the field of general international law. To reflect this broader focus, the group will be (re)named **TLS Reads!**. The reading list for *TLS Reads!* will include publications on a generality of topics from the field of international law, and will focus more particularly on recent publications by fellow international lawyers. The aim will be to provide a platform for colleagues where we can gather to discuss contemporary publications and developments in international law. Interested colleagues will also have the opportunity to suggest readings, so that we can make sure that the group covers a broad range of interests. This group will meet once a month for one and a half hours, and will be open to all interested colleagues. The first meeting with the new format will take place in **January 2020**, and the exact date as well as reading material will be announced after the holidays.

In addition to TLS Reads, we have decided to also explore the option of maintaining a smaller reading group which will focus on readings specifically from the field of legal theory. Therefore, as of **February 2020** we will launch a pilot group called **TLS Reads Classics**. The aim of *TLS Reads Classics* is to address the more specialized interest of some colleagues to read and discuss seminal works of legal theory. Since the group will focus on reading foundational works of legal theory, it will also be open for interested LLM students. The pilot trial for this reading group will go on for three months, and will show us whether it is viable and necessary to maintain two separate reading groups, one of which is open for student participation.

Colleagues are welcome to join one or both of the reading groups. Please note that joining the reading groups is completely voluntary, and is meant to be a flexible and enjoyable activity. The meeting dates and times for the new reading groups will be announced in January 2020.

SEMINARS, EVENTS, WORKSHOPS AND CONFERENCES

Anne Ruth Mackor and **Hylke Jellema** organized a “North Sea Group on legal evidence and proof” (NSG) **workshop on evidence and proof in criminal law** (7-9/11/2019).

The topic of this workshop was Bayesian and explanation-based approaches in criminal trials and the relationship between them. Bayesian and explanation-based approaches are possibly the two most influential ways of thinking about legal evidence and proof at the moment. Much has been said about their relationship, but even more remains unclear. Do these approaches exclude one another or can they be combined? Furthermore, if they are compatible, do they simply exist side-by-side or can they inform one another? Finally, are both approaches legally and psychologically feasible? The workshop therewith was a truly transboundary legal study (TLS).

Norman Fenton - Resolving the so-called probabilistic paradoxes in legal reasoning with Bayesian networks, Comments by Frank Zenker and Amit Pundik

Anne Ruth Mackor - Different ways of being naked. A scenario approach to the naked statistical evidence problem, Comments by Ronald Meester

Christian Dahlman - Naked Statistical Evidence and the Futility of Lawful Conduct, Comments by Marcello di Bello

Leah Henderson - IBE and Bayesianism in legal settings, Comments by Martin Neil

Eivind Kolflaath - Bayesian networks, and a distinction between causal models and proof models, Comments by Ruta Lipiena
