4. Brief summary of research over the last five years

As rural sociologist I principally worked in the field of European rural development, policy and practice, and focused throughout the years on the then key themes: rural entrepreneurship, governance and gender, then production ethics, and currently the main challenge in Europe: social innovation and the marginalisation of rural areas. Most of my research is comparative and internationally oriented.

Studies into citizens' trust in food, and farmers' reactions to tightening animal welfare regulations deepened my insight into the drivers of rural transformation and the importance of a combined rural-urban perspective. Studies of rural entrepreneurship demonstrated the genderedness of livelihood diversification. In studying emerging governance processes in rural and agricultural policymaking I gained insight in the mechanisms of social exclusion in participatory policy processes and in the need to look beyond singular areas when studying placed-based development processes. Recent research into the position of rural women across Europe underlined the urgency of more research into the remote areas that takes account of increasing levels of migration and depopulation. Studying social innovation highlighted the resilience of rural society especially in the light of the financial crises and stresses the opportunities it offers for neo-endogenous development processes.

Implementing this research gave me extensive experience in the management of large international projects, the supervision of researchers and PhDs, the dissemination and valorisation of research results, and enabled me to build an extensive international network of academics, policy makers and practitioners.
